Our Programs

FOOD DISTRIBUTION



MVFB's Food Distribution program collects, safely stores, and distributes food from the USDA, Massachusetts Emergency Food Assistance Program, food company and individual donations. Food is distributed to a network of more than 100 member agencies, such as food pantries, meals programs, shelters, and schools, bringing food to people right in the neighborhoods where they live, work, learn, and play.

MOBILE PANTRY



The Mobile Pantry makes personalized monthly grocery deliveries to homebound seniors and individuals with disabilities in Greater Lowell, tailored to their dietary needs and food preferences. This program served over 300 individuals a month and also provided bags of food for 200 people at the Lowell Senior Center. Altogether, more than 100,000 meals were distributed in FY25.

OPERATION NOURISH



Operation Nourish provides food for students to enjoy on weekends and vacations when they are not getting school breakfast and lunch. Through a combination of take-home bags and in-school food pantries, the program serves students in 35 schools. In FY25, Operation Nourish distributed 166,376 lbs of food to students.

Our Programs



SUMMER EATS

During the summer, MVFB partners with the USDA to provide healthy lunches and snacks to children and teens participating in summer activities in Lowell. The MVFB team prepared and distributed 12,453 lunches and snacks during July and August of 2024.



COMMUNITY MARKET

MVFB's Community Market is a free farmer's market that occurs monthly from June to November at seven low-income and senior housing properties in Greater Lowell. The FY25 markets distributed food to an average of 346 people a month, providing 23,862 pounds of nutritious food during the market season. Attendees also received a supermarket gift card in November to help with the cost of holiday meals.



FOOD RESCUE

MVFB's Food Rescue program picks up fresh food from grocery stores. These are items that might be overstocked, nearing their expiration dates, or considered "ugly" produce, but are still good to consume. Items include fresh produce, deli and bakery items, and prepared salads and sandwiches. In FY25 this program diverted 131,074 pounds of food from the landfill.

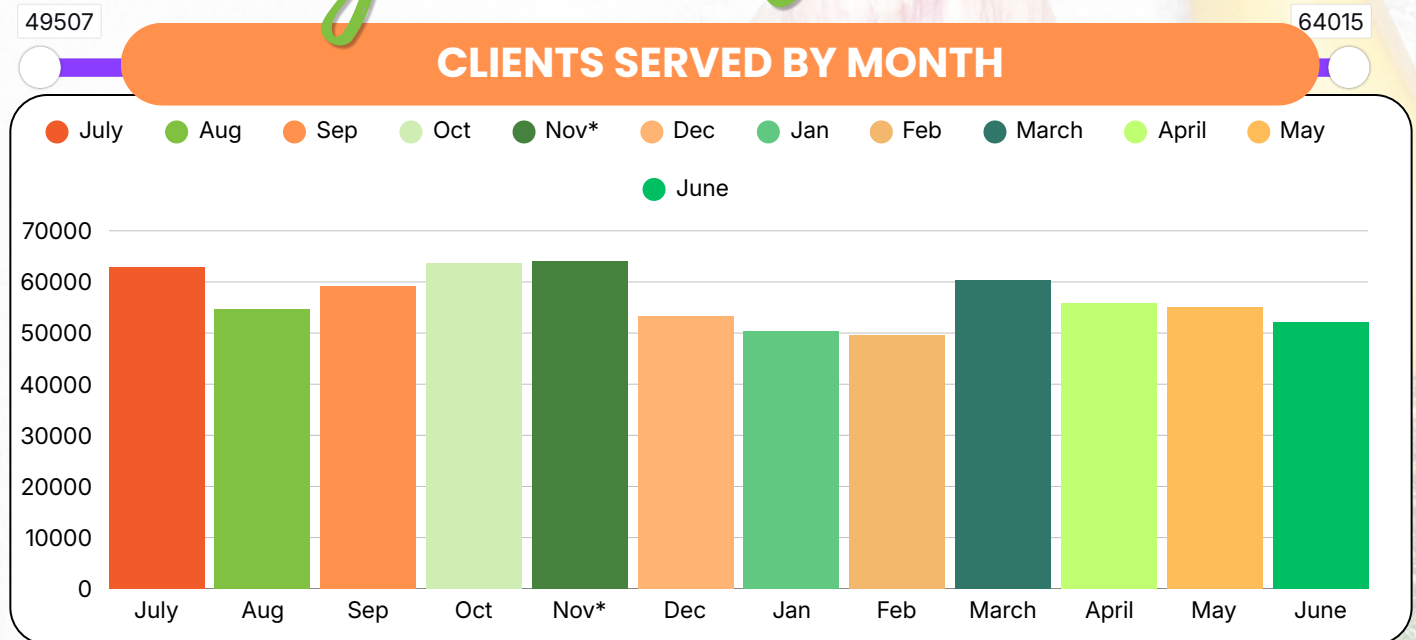
